RE: Private Members Bill C-377

Greetings:

Private Members Bill C-377, An Act to amend the Income Tax Act (requirements for labour organizations) was passed in the Senate on Tuesday, June 30th, 2015 by a final vote of 35-22, with one abstention. This was a long hard-fought piece of legislation, and I would like to thank each and every member that participated in our lobby efforts; whether they contacted their MP while the bill was in the House of Commons, or contacting Senators from their province to express their discontent with this union-busting bill. Fact is, the lobbying efforts of IBEW members from across the country were heard by politicians of all party stripes and in both chambers of parliament. While the final result was not one that we desired, our efforts should be commended.

This legislation has been flawed from the day it was drafted; however, with the un-wavering support it had from the Prime Minister's Office, we knew we had an uphill battle from the outset. Bill C-377 was first introduced almost four years ago, October 2011.

The Conservatives used their majority in the House of Commons to shut down debate in Committee hearings and in the House in order to ram the bill through before the Christmas break of 2012. It was such a priority that less than twelve hours after passing in the House of Commons, it was sponsored and introduced for first reading in the Senate.

In June of 2013, it appeared that we had scored a small victory with Senators passing amendments put forward by Conservative Senator Hugh Segal; however those were quickly nullified by the Prime Minister's decision to prorogue parliament, which essentially reset the bill back to its original form, and back to first reading in the Senate.

Below you will find the results from Hansard of the final vote in the Senate on the bill, along with the Senator's name and home province. I would encourage you to share this information with our membership.

It should be noted that although Senator Doug Black from Alberta abstained from voting in the final vote, he did vote in favour of limiting debate in the Senate, and voted to overrule the Speaker's ruling, which in turn led to the final vote on C-377.

In the final tally, there were three brave Conservative Senators who voted against the bill along with two independent Senators. Our lobbying efforts have asked our Local Union leaders and our members to contact their MP's and Senators many times in the past in hopes of defeating this legislation. I would ask you to contact the Senators one final time who voted against this bill (NAY's) and thank them for their efforts to protect not only the many men and women in the labour movement but the many more who will be captured by this broad sweeping bad legislation.
